9. Extend 2018 Code Effective Date	There was much discussion and many written testimonies for and against moving the code effective date from February 1, 2021.
	Hoyt Jeter, Senior Structural Reviewer at City of Tacoma is against the extension.
	Carolyn Logue is for extending the date to at least March 15, 2021. to allow extra time for supply chain issues and compliance.
	Ardel Jala, Building Official for the City of Seattle, opposes the delay of the 2018 Washington codes effective date and we request SBCC to keep it at February 1, 2021.
	Name unheard- From the Northwest Association and Training Center is for the extension.
	Damen Jeg with BIAW, is for the effective date delay to March 15, 2021.
	John Catlett, Senior Code Consultant for BOMA International is for moving the effective date to at least March 15.
	Jason Gano, Master Builders, asked a clarifying question to the decision for City of Seattle's extension to March 15, which Ardel Jala, City of Seattle, responded to.
	Steve Wilson, City of Kent Building Official is in opposition of delaying the code effective date.
	Someone on the phone is for the delay of the IFC code pertaining to a certification of a portion of the code (sound quality issues).
	Ryan Makinster, Clark County is for delaying the effective date.
	Mike Lubliner, WSU Energy Program, stated that the forms are available on their website and they are available to assist.
	Hoyt Jeter mentioned that the WSU Energy website has training

	videos, as well.
	Senator Wilson is for extending the code effective date to March 15, 2021.
	There was a lot of discussion among the Council members regarding a July 1, 2021 effective date.
	Council did vote to approve an effective date of the 2018 codes to July 1, 2021.
