Agenda Items	Committee Actions/Discussion
1. Welcome and Introductions	Meeting called to order at 9 a.m. by Kjell Anderson, Committee Chair. Everyone was welcomed and roll was called. <b>A quorum of the Committee was not present.</b>

Revisit Opinion 22-02: Cited efficiency values	While there is not a quorum of Committee members present, the Chair did entertain comments from those attending on the status of a crosswalk between the old and new efficiency. Krista Braaksma reported that there was nothing new published by the US Department of Energy. Elliott Brown from Johnstone Supply stated he did not believe anything would be out until June. There was some discussion of new language that could be put forward for the Council to consider for a reissuance of this opinion.
