Requests to Delay the Energy Code Effective Date</p>	<p><b>Motion:</b> Kjell Anderson moved to delay the effective date of the Energy Codes under Emergency Rulemaking on June 30, 2023, for 120 days to address issues of the Codes and for training purposes, Roger Heeringa seconded.</p> <p>Kjell Anderson spoke to his motion as did Roger Heeringa as seconder.</p> <p><b>Motion with amendment</b> by Kjell Anderson begin the rulemaking process by filing a CR-101 to make modifications to the Commercial and the Residential Energy Codes to reduce the risk related to the <i>California Restaurant Association vs City of Berkeley</i> decision relative to EPCA and to convene TAGs for both the Commercial and Residential Energy Codes, Roger Heeringa seconded, the motion passed.</p>
