1107.1 General.

Electrical vehicle charging stations shall comply with Section 1107.2. Fuel-dispensing systems shall comply with Section 1107.3.

1107.2 Electrical vehicle charging stations.

Electrical vehicle charging stations shall comply with Sections

1107.2.1 and 1107.2.2. be provided in accordance with Section 429.4.

Exceptions:

- 1. Electrical vehicle charging stations provided to serve Group R-3 occupancies are not required to comply with this section.
- 2. Electric vehicle charging stations used exclusively by buses, trucks, other delivery vehicles, law enforcement vehicles and motor pools are not required to comply with this section.

1107.2.1 Number of accessible vehicle spaces. See Section 429.4.

1107.2.2 Vehicle space size.

Accessible vehicle spaces shall comply with the requirements for a van accessible parking space that is 132 inches (3350 mm) minimum in width with an adjoining access aisle that is 60 inches (1525 mm) minimum in width.

1107.3 Fuel-dispensing systems. Fuel-dispensing systems shall be accessible.

Sections 1107.2.1 and 1107.2.2 of the 2021 IBC specify requirements for the number and size of accessible vehicle spaces served by EV charging systems. WA State Amendment Section 1107.2.1 deletes the base language and instead references state amendment section 429.4, which sets different EV charging requirements for accessible <u>parking</u> spaces, not accessible <u>vehicle</u> spaces.

State requirements for the size of accessible parking spaces (8'parking/5'access aisle for cars; 8' parking/8'access aisle for vans) are different from the sizing specified for accessible vehicle spaces in Section 1107.2.2. Also, state requirements do not recognize accessible vehicle spaces, therefore Section 1107.2.2 is not scoped and is not applicable. Because of this, we propose to remove IBC Section 1107.2.2 in order to avoid confusion. Additional modifications include the reference to Section 429.4 directly from Section 1107.2.
