1. Welcome and Introductions	Committee Chair, Tom Handy called the meeting to order at 2:02 p.m. Roll was taken and a quorum was not established. At 2:09 a quorum was established.
2. Review and Approve Agenda	Jay Arnold moved to approve the agenda, Kjell Anderson seconded, the motion passed.

4. He pointed out Dead and Alive Bills and also pointed out the amendments made in SB 5552 – Kit Homes. Dustin Curb said the “week ahead” currently doesn’t have any items pertaining to the SBCC. Todd Beyreuther mentioned working with Roger Heeringa on items for the upcoming BFRW Committee meeting. He also inquired about the status of 2SHB 1183, and Dustin Curb advised the elevator language had been removed from the bill, so it no longer impacted the SBCC.
