Agenda Items	Council Actions/Discussion
Welcome and Introductions	The meeting was called to order at 10:00 a.m. by Council Chair Todd Beyreuther. Roll call was taken, and a quorum was present. Anyone from the public, who wished to, introduced themselves.
2. Review and Approve Agenda	Motion: Kjell Anderson moved to approve the agenda, Tom Handy seconded, the motion passed.
Review and Approve Minutes January 21; February 6	The minutes were not ready for review.

4. Public Comment on Items Not on the Agenda	Public comment was heard in favor of the SBCC not making changes prior to a decision made on I-2066 and continuing on with their progress of the Codes.
5. Energy Code TAG Request	Todd Beyreuther provided a brief background of the Executive Committee's discussion on this topic which led to it being brought to the full Council for further discussion.
	Kjell Anderson, TAG Chair, indicated the Council should make the decision "Site vs Source" (Section C101.3.1; basis of site or source energy consumption) and it was noted that EPCA refers to "Site."
	Gregory Johnson provided a <u>presentation</u> referencing 24-GP1-206.
	The councilmembers asked questions about the presentation, which were answered by the presenter.
	Public comment was heard indicating the presentation was biased and one-sided but other comments were heard in favor of the presentation.
	Todd Beyreuther provided a recap of the intent for today's meeting was to review the proposal, open up for written comment and allow verbal comments at the March Council meeting.
	Motion: Daimon Doyle moved to open public comment period for proposal 24-GP1-206, direct the WSEC TAG to continue with site energy, hold a hearing at the next Council meeting with encouragement for written testimony and limited time for verbal testimony, and inquire with AGs office if using source puts the Council at risk in relation to EPCA, Tom Handy seconded, the motion passed.
6. Local Amendment: Airway Heights	Mike Makela presented the Local Amendment: Airway Heights Residential Sprinkler amendment to 2021 IRC.
	Councilmembers asked questions about the proposed amendment which were answered by Mike Makela. Public comment was heard in opposition to approving without a public hearing for the people affected by this amendment. There was support of the amendment and also concern with the proposed language. It was suggested the petitioner take SBCC comments back to their local Council and allow public comment and return to SBCC, if necessary. It was noted the amendment must be approved or denied within 90 days of receiving the request.
	Motion: Daimon Doyle moved to table indefinitely, Tom Handy seconded, the motion passed 9 to 2.
