He highlighted 2 petitions that still need Council approval and noted these would be on the Council agenda in September.

There was discussion held on the depth of information required and the WGEI Rating. It was noted the TAG Chairs review and input was greatly needed to determine if additional review was needed by the TAGs and if a survey would need to be sent out to find additional impacts to small businesses. Dustin Curb provided a review of the ORIA SBEIS template that could be used in the process.
