Legislative Update: <ul style="list-style-type: none">• HB2141 - Building Codes	<p>This "Special" Legislative Committee meeting was called to discuss the movement of HB 2141 as a public hearing was scheduled for Tuesday, February 3 at 10:30 a.m. and the Committee is meeting to discuss whether they should provide testimony or not.</p> <p>The Committee discussed the general concerns for SBCC, the Council, TAGs, the State, the Codes, and Staff, if this Bill were to pass, and it was decided to create some informative talking points to present at the public hearing. Discussion was held on availability of Councilmembers and Staff. Angela Haupt indicated she would be available to provide testimony and Dustin Curb said he would be available for questions or to clarify information at the public hearing and Dustin Curb would sign up to testify.</p> <p>Motion: Jay Arnold moved to have a committee member testify tomorrow on HB 2141 covering the talking points discussed today with Roger Heeringa, Angela Haupt, Jay Arnold, Todd Beyreuther, Tom Handy, and Dustin Curb preparing testimony, Angela Haupt seconded, the motion passed.</p>
